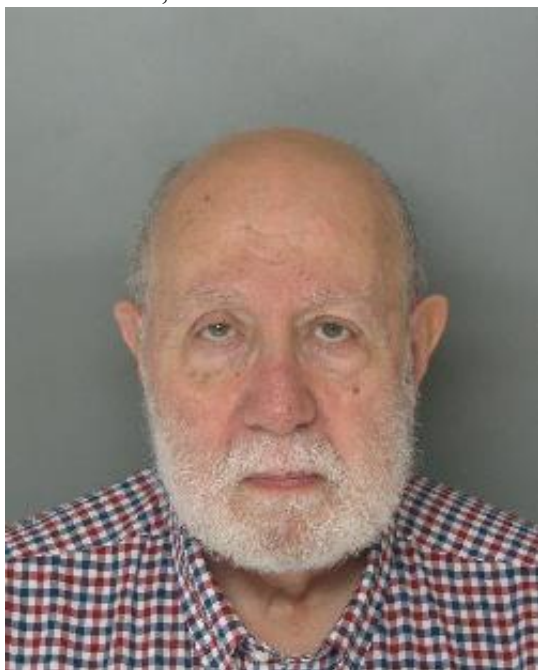

- This criminal offense involved the forcible commission of a **sexual contact** (http://www.dpscs.state.md.us/onlineservs/sor/sor_crimes_article.shtml#301f). The registrant was a stranger to the victim. When the offense occurred the victim was a middle school aged child. The offender was 56 years of age. Court records for this case indicate that the registrant's sexually abusive behavior occurred once.
