WITH INTENT TO CAUSE SERIOUS PHYSICAL INJURY TO ANOTHER PERSON, CAUSE SUCH INJURY TO SUCH PERSON OR A THIRD PERSON; HE KNOWINGLY ACT IN A MANNER LIKELY TO BE INJURIOUS TO THE PHYSICAL, MENTAL OR MORAL WELFARE OF A CHILD LESS THAN SEVENTEEN YEARS OLD OR DIRECT OR AUTHORIZE SUCH CHILD TO ENGAGE IN AN OCCUPATION INVOLVING A SUBSTANTIAL RISK OF DANGER TO HIS LIFE OR HEALTH; SUBJECT ANOTHER PERSON TO SEXUAL CONTACT WHEN SUCH OTHER PERSON WAS LESS THAN FOURTEEN YEARS OLD; SUBJECT ANOTHER PERSON TO SEXUAL CONTACT WITHOUT THAT PERSON'S CONSENT AND SUCH OTHER PERSON'S LACK OF CONSENT WAS NOT DUE SOLELY TO INCAPACITY TO CONSENT BY REASON OF BEING LESS THAN SEVENTEEN YEARS OLD AND SUCH OTHER PERSON WAS MORE THAN FOURTEEN YEARS OLD AND THE DEFENDANT WAS LESS THAN FIVE YEARS OLDER THAN SUCH PERSON.
