I wish to receive a photo and arrest report of the individuals named below. If the individual has been incarcerated and released, I also want to know the amount of time the individual was incarcerated. If I haven't identified the disposition of the case, please also inform me of the disposition.

1) Arthur Samet

He was prosecuted by the Brooklyn DA. Pleaded guilty to Endangering the Welfare of a Child, sentenced to 3 years probation on 11/2/09.

2) Boris Shaulov

DOB – 8/18/85

SS – 093-84-7276

He was prosecuted by the Brooklyn DA. Pleaded guilty to two counts 3rd Degree Rape; 3rd Degree Criminal Sexual Act; Endangering the Welfare of a Child, sentenced to 2 years in prison on 4/5/2012. Placed as level 1 sex offender.

3) Chaim Becker

He was prosecuted by the Brooklyn DA. Pleaded guilty to 3rd Degree Sexual Abuse, sentenced to a conditional discharge and community service 10/31/11.

4) David Klausner

He was prosecuted by the Brooklyn DA. Pleaded guilty 2nd Degree Criminal Sexual Act, sentenced to a conditional discharge on 12/16/2014 and placed in a program.

5) Eli Belili

He was prosecuted by the Brooklyn DA. Pleaded guilty to Endangering the Welfare of a Child, sentenced to a conditional discharge 1/29/13.

6) Israel Nivazou

He was prosecuted by the Brooklyn DA. Pleaded guilty to Attempted Forcible Touching. Sentenced to a year probation 4/19/10.

7) Jacob J. Kaff

DOB – 3/25/79

SS – 053-76-9959

He was prosecuted by the Brooklyn DA. Pleaded guilty to 2nd Degree Course of Sexual Conduct Against a Child, sentenced to 3 years in prison 6/18/13.

8) Nathan Actman

He was prosecuted by the Brooklyn DA. Pleaded guilty to Sexual Misconduct, sentenced to 6 years probation on 3/19/2009. Placed as level 1 sex offender.

9) Nuchum Hammerman

He was prosecuted by the Brooklyn DA. Pleaded guilty to Attempted Endangering the Welfare of a Child, sentenced to a conditional discharge 10/16/12.

10) Sheldon Siller

He was prosecuted by the Brooklyn DA. Plead guilty to 2nd Degree Criminal Contempt, sentenced to 3 years in prison on 2/28/2012.

11) Solomon Marmorstein

I don't know where or when he was prosecuted. He was convicted of Attempted Endangering the Welfare of a Child.

12) Tzvi Boxer

DOB – 1/2/78

SS – 053-76-9959

He was prosecuted by the Brooklyn DA. Pleaded guilty to 1st Degree Course of Sexual Conduct, sentenced to 10 years in prison on 6/12/13. I don't know when he was arrested. He is currently incarcerated in Green Haven DIN – 13A2825.

13) Yaakov (Jack) Maimon

DOB – 2/11/79

SS – 062-64-5119

He was prosecuted by the Brooklyn DA. Pleaded guilty to 1st Degree Sexual Abuse, sentenced to 2 years in prison on 2/28/2011. Placed as level 1 sex offender.
