Sentence

1. The defendant was convicted, based on his confession, of the offense of an indecent act against a minor, according to section 348 (b) with the addition of section (B) (1) and in the circumstances of section 345 (a) (1) of the Penal Law in the first indictment, and the offense of sexual harassment under section 4 with the addition of section 5 (a), under the circumstances of section 3 (a) (3) of the Prevention of Sexual Harassment Law, in the second charge. And these actions are the subject of the first charge and as described in the indictment amended again: On 02/19/12, the city of Beit Shemesh, in the afternoon, being a defendant in the street, he turned to the complainant, a minor born in 2003, she walked towards her and asked where she lived. The defendant took the complainant girl to a nearby parking lot and told her, after he had laced her shoelaces: "I'm doing something a little scary, agree?" The defendant reached into her skirt and rubbed her penis under her panties against her will and despite her attempts to evade him. Then the defendant asked the girl to touch his penis, took her into the garage, took off his pants and underwear, took her hand, put it on his penis, and asked her to rub his penis, and so she did. The defendant continued to rub his penis until he was released. After the acts, the defendant asked the girl not to tell anyone about the acts. In the second charge, on February 4, To another girl, who was born in 2002, on a street in the city of Beit Shemesh, and asked for her age and place of residence. The defendant told this girl that he needed help, led to a nearby parking lot, where he told her that he wanted her to touch his penis. The girl refused and the defendant told her that he wanted to touch her penis. The girl told the defendant that she was afraid and the defendant allowed her to go home.

2. The Defendant is 29 years old, convicted of an indecent assault on minors in 2004, in which he served a six-month prison sentence for service. The Defendant's actions within the scope of this conviction are set out in the sentence that was submitted by the Defendant .
